Forestry Strategic Planning for the New Administration Participated in by the PWPA

Wood Philippine Association Producers attended the (PWPA) forestry sector workshop Forestry Strategic Planning for the New Administration hosted by the Forestry Development Center (FDC) held on May 29, 2010 at the UPLB - College of Forestry and Natural Resources (UPLB-CFNR), College, Laguna.

FDC Director Antonio Carandang, workshop chair, made the rationale of the meeting as to discuss and agree on the forestry agenda to be presented/ recommended to Presumptive Presidentelect Benigno C. Aguino III, the new DENR secretary and the 15th Congress.

Former DENR Usec Ricardo Umali presented for discussion a shopping list of key forestry concerns and the outline of the paper presentation to the incoming President.

The participants from UPLB-CFNR, Forest Management Bureau, National Power Corporation, Society of Filipino Foresters and PWPA recommended the list be classified into general issue-

headings of poverty reduction and antipolicy and enabling legislation would try to address them. The two headings came from the campaign materials of Novnov Aguino while the recommendations, from the forestry sector.

PWPA ED L. D. Angeles distributed an Inquirer article about the environmental agenda, including forestry, of Noynoy Aguino as he suggested that implemented parts of the recommendations of the forestry sector should include them for obvious good reasons.

> The forestry sector's strategic plans toward attaining a functioning sustainable forest management would materialized sooner than later if its legal and administrative requisites would be satisfied such as the passage into law of the SFM Act; an Act to declare as permanent forestlands all areas classified as such by DENR-NAMRIA; and to adopt the Master Plan for Forest Development first formulated in 1990 and revised in 2003.

PWPA Joins Arbor Day Celebration

he Philippine Wood Producers Association led by its President, Antonio Olizon, and VP-Director, Ramon Uy, participated in the Department of Environment and Natural Resources -National Capital Region (DENR-NCR) Arbor Day Celebration held at the National Bilibid Prison Reservation, Muntinlupa City on June 25, 2010.

A short program preceded the tree planting. Mr. Willie Marquez of the Bureau of Corrections (BuCor) welcomed and thanked the participants for joining the Arbor Day celebration.

Jose Camacho, an NGO representative. expressed his organization's support to the environmental program of the DENR in the area.

BuCor's Asst. Director Mercado recalled that Arbor Day was celebrated nationwide with school children required to plant trees but which tradition seems not continued anymore. He emphasized that planting a tree is not the end of the activity; it is only the beginning but its maintenance and protection is very important. He offered the services of the inmates in a continuing tree planting in the reservation but he requested logistics support from the city government and the private sector.

PWPA President Antonio Olizon traced the origin of the Muntinlupa nursery, as a joint project with BuCor and DENR in the 1990s to provide seedlings to different government and civic tree planting projects. The inmate-workers were, and even as now, given small allowance, trained and given certificates of skill completion to prepare them when they joined the outside community. He said as one of PWPA's CSR projects, the nursery was lately revived.

DENR-NCR Regional Technical Director for Forestry (RTD-F) Laureano Lingan, Jr. closed the program by thanking everyone who came to participate in the Arbor Day Celebration. He said joint collaborative efforts of all sectors is important for the success of any endeavors for the environment.

About two hundred native trees like narra, amugis and dao were planted in the designated area above the small man-made lake.

The planting activity was participated by representatives from DENR-NCR led by RTD-F Lingan, Jr.; PWPA, by President Olizon; BuCor, by Asst. Director Rod Mercado; NGO, by Mr. Camacho: and Philippine Lumber Merchant Association, by Mr. Aquino Lee.

PWPA & FMB Meet after the Joint Workshop at AIM

he Philippine Wood Producers Association (PWPA) and the Forest Management Bureau (FMB) met on May 25, 2010 at the FMB, . Quezon City to continue the discussion of wood industry concerns started during their joint workshop on April 27, 2010 at AIM.

The Minutes of the Joint Workshop prepared was reviewed (copies earlier sent to FMB) and a manifestation for its approval was made by PWPA Executive Director L. D. Angeles. Because of some clarification on the item on the suspension of the clearing of natural vegetation in degraded residual natural forest in IFMA areas, the manifestation was withdrawn by the PWPA with the request that the Minutes be approved in the next meeting.

FMB Director Marlo Mendoza made an update on the following concerns:

 On the Suspension on the clearing of natural vegetation in degraded residual natural forest in IFMA areas. The FMB suggested the issuance of a clarification to the October 8, 2009 Memorandum - instead of suspending it as suggested by the PWPA - if the amendments to DAO 99-53 were not approved by the Secretary by the end of May 2010. The PWPA suggested a hearingmeeting on the intended clarification.

The FMB suggested a re-definition of degraded residual natural forest as maybe borne by a study being done by NAMRIA on correlating the crown cover with the basal area.

On Surface Rights conflict between TLA/IFMA-holder and the FTAA-/MPSA-/small-holder mining permitholders. The DENR/FMB and the DOE have already effected coordination between them (in case of coal and oil/gas found in TLA/IFMA areas) and among DENR agencies like the EMB (in the issuance of ECCs) and the MGB (in the case of minerals/quarries found in TLA/ IFMA areas). GIS maps as references of conflicts are being shared among the said agencies/bureaus.

The MGB requires a certification from FMB while the order on Forest Land Use Agreement cum Tourism. EMB decides on its own through first come first serve implemented at the regional level.

The PWPA suggested a DOJ opinion on the surface prior right issue.

On Inclusion of African oil palm plantation inside IFMA areas. The FMB insisted that African oil palm will be allowed to be planted only within the fixed 10% of the IFMA area intended for agricultural purposes, consonantly with MC 2004-12 in relation to DAO 99-53.

In other words, its planting in the rest of the IFMA area, the FMB did not initially consider favorably.

On the profit-sharing agreement between the IFMA holder and the government. The FMB presented for consideration a "universal" formula from which three (3) different computations for the said profit sharing were developed. One that maybe agreed upon shall be used for Luzon, Visayas and Mindanao with corresponding regional "correction factor."

The PWPA did not object to the "universal" formula but it asked to be furnished with the computations/data behind them for its further study.

It also manifested that the profit sharing be equitable, incentive-friendly, contract-to-contract applicable and easy to implement like on percentage basis.

On Portfolio Approach to attract investment. The DENR Secretary wants to push through the said FMBrecommended approach as he instructed the REDs, to identify two sites per regions as pilot areas therefor.

PWPA suggested to consider the following MUST criteria in identifying the pilot areas: clear of entrants; close to ports or to processing plants; connected to infrastructure (roads, power, etc.).

The FMB is also suggesting the establishment of industrial forestry zones, similar to the industrial processing zones, to provide more incentives to investors.

In relation to its IFMA area in Morong, Bataan, the PWPA explained its concepts for developing the area as a mix adventure, leisure and educational nature park or ecotourism in addition to the usual, allowed forestry development and management practices under the IFMA.

The FMB expressed no objections to the development concepts but it suggested that they be implemented within the regulation-prescribed 10% of the total IFMA area although other permissible activities may be undertaken on the forestland use track as specified in the department

Snapshot of the Tropical Timber Market

Continuing uncertainty clouds European market

Markets for tropical wood products in Europe remain subdued following uncertainty over the sustainability of EU economic recovery. The construction sector – particularly new residential activity –remains very weak across Europe.

In addition, the weakening of the Euro and rising freight costs are reinforcing the already strong tendency amongst EU importers to keep stocks low and place only small orders. The lack of availability and long lead times for tropical wood products are a significant hindrance in this market environment with the result that tropical wood risks losing market share.


In the sawnwood sector, some European manufacturers are replacing tropical wood with temperate species, while South East Asian plywood is facing stiff competition from Russian birch and Chinese plywood products.


However, hardwood demand is benefiting in some parts of Europe from housing renovation activity.
