



THE WOOD INDUSTRY IN REVIEW

The barrage of policy changes instituted by the government in early up to mid 1989 had its initial telling impact on the year-end performance of the wood industry.

As the preceding comparative statistical data reveal marked production and export downtrend characterized this performance.

Raw Material Supply

Access at local raw material (log) supply became difficult due to the following government policy factors:

- The reduction of production forest area by 49% (from 4,316,000 hectares down to 2,205,000 hectares);
- The reduction of annual allowable cut by 48% (from 6,984,000 cum down to 3,623,000 cum);
- The expiring of TLA's, that reduced the number of licensees from 103 to 81 and the slow implementation of TPSAs;
- The non-lifting of the moratorium on logging, especially in Samar; and
- The constraints imposed by new regulations such as no logging in old growth forest with slopes 50% and steeper, no logging in more than one side, the restriction on the use of usual yarders, and the ban on the export of lumber as well as the unsettling peace and order condition in some logging areas.

Access at imported raw material (log) supply was not encouraged any by the government ruling that only highly finished products manufactured therefrom are allowed for export.

Production

Because of aforementioned factors production of logs and primary timber products was generally down in contrast with the preceding year.

Log production was down by 16% (from 3,809,000 cum to 3,200,000 cum); lumber by 8% (from 1,033,000 cum to 951,000 cum); plywood

by 18% (from 415,000 cum to 342,000 cum); and, veneer by 24% (from 85,000 cum to 65,000 cum).

Aggregate production of primary timber products in 1989 was lower by nearly 12%, volume-wise, compared with 1988.

Market

Of the 1989 aggregate production of primary timber products, 45% went to the export market and 55% was apparently absorbed by the domestic market (the 1988 ratio was 62% and 38%, respectively).

Two factors that occasioned this market share switch and/or a lower export volume were:

- The impact of the lumber export ban which took effect in July 1989; and
- The softened export market for plywood.

Nonetheless, there was no indication whether or not the retained 62% of entire timber product production volume was actually absorbed by the domestic market or simply stocked up as inventory. Obvious, however, was the 25% overall drop in FOREX export revenue.

Compared with 1988, 1989 falcata log export was down by 37% (from 174,000 cum to 110,000 cum) with corresponding 22% revenue reduction (from US\$8.0 million to US\$6.3 million); lumber by 30% (from 629,000 cum to 438,000 cum) with a 13% revenue reduction (from US\$156.5 million to US\$136.20 million); plywood by 52% (from 243,000 cum to 116,000 cum) with a 51% revenue reduction (from US\$78.8 million to US\$38.5 million); and veneer by 19% (from 79,000 cum to 64,000 cum) with a 17% revenue reduction (from US\$21.0 million to US\$17.4 million).

Aggregate export volume and revenue reductions were 397,000 cum, or 35% (from 1,125,000 cum to 724,000 cum) and US\$66 million or 25% (from US\$264.3 million to US\$198.4 million), respectively.

The softened export demand of plywood that lessened FOREX revenue by about US\$40 million could have been covered up by a 25% increase in fob unit price of lumber in 1989 if not for the 30% lumber export volume reduction foregone due to its export ban.

Major Issues Faced

During the year under review, the industry was faced by a number of critical issues that placed it in a state of flux.

The effects of promulgated new regulations, the portent of more administrative policies emanating from recommendations of the MPFD as well as a legislative enactment of a logging ban, the pressure

of the environmental movement, and the dormancy of positive actions needed to address key problems will continue to tell on the future stability or viability of the wood industry.

Elsewhere in this Report is a summary of attempts of your Association at tempering adverse impacts of the policy environment obtaining in 1989.

THE ASSOCIATION

Your Association acted promptly to counteract the enactment and promulgation of legislative and regulatory measures which would have put further stress and strain on an already weakened wood industry. We argued our case in Congress against a total logging ban. We had an audience with President Aquino and briefed her about the industry performance, and promise, as we presented to her immediate problems of our industry.

Your Association campaigned hard using various forms of media to countervail the misinformation being peddled by the conservation movement. Your officers appeared in radio and TV programs and in public fora to highlight the true and correct picture of the wood industry.

It may be said that the threat of common problems and the need to consolidate common efforts at addressing them have strengthened the bond of unity among us still active in the wood industry. Those not with us in the past are with us now — as maybe gleaned from the growth in active membership, from 224 in 1988 up to 235 in 1989. The sincerity of our members to their commitments to help to boost forest conservation was clearly demonstrated by their judicious application of the


reforestation trust fund — that between September 1988 and up to end of December 1989 totalled P344,138,319.07 — in reforesting open and denuded areas.

Your Association continued to be active in regional forestry and wood industry activities. At the end of December 1989, our PWPA President Antonio G. Bernas and L. D. Angeles had completed their two-year term as Chairman and Secretary-General of Southeast Asia Lumber Producers Association (SEALPA), respectively. Before leaving their posts, they drafted the charter and rules of the Asia-Pacific Tropical Timber Organization (ATTO), the new regional organization to take the place of SEALPA. PWPA Chairman Ernesto F. Sanvictores, as Vice Chairman of ASEAN Panel Products Federation, together with our Plywood Council Chairperson, Director Edith I. Alcantara, have been ably representing our Association in APPF.

Finally, the sincere gratitude of the Board of Directors and Officers is hereby extended to all our members whose full cooperation and unstinted support have allowed our Association as well as our industry, to survive yet another year despite tremendous odds. In constant unity we will prevail.

1989 ACCOMPLISHMENT HIGHLIGHTS

1.1 Calculating AAC from operable old growth (virgin) forest only, excluding residual forest (DENR Adm. Order 21, Series 1989).	1.1. 4. Banning of logging in old growth forest with slopes 50% and steeper and 1,000 m. and above in elevation (DENR Adm. Order No. 25, Series 1989).	4. PWPA appealed the matter of slope limitation as it is not only very difficult to implement but will substantially reduce operating areas and by extension reduce also AAC/timber production.	4. The DENR has denied this request.

5. On the implementation of DENR Adm. Order No. 79, Series 1988 (as amended by DAO No. 32, DAO No. 63, and DENR Circular No. 1, all Series of 1989).

5.1 Clarification as to the use of the deposit under the Reforestation Trust Fund (RTF).

5.2 Reforestation performance of TLA holders shall be based on area planned to be logged per their IAOP's.

5.3 Retroactivity of reforestation performance ratings and penalties for poor performance (DENR Adm. Order No. 125, Series 1989).

5.4 The use of native, e.g. dipterocarp species in reforestation.

5.5 Schedule of the payment of RTF deposits for 1st and 2nd quarters of 1990.

6. The payment of annual license fees by TLA holders have always been based on old AAC.

7. Extension and/or renewal of private timber production area.

8. Master Plan for Forestry Development several recommendations that have serious impact on the industry; *inter alia*:

8.1 No logging in virgin forest; and

8.2 No high lead yarding nor use of logging equipment in excess of 200 hp.

5.1 PWPA has the understanding that no less than half of the RTF deposit shall be used for reforesting open denuded areas and the rest maybe used for TSI.

5.2 PWPA requested DENR that reforestation performance be based on actual area logged and not on the area planned to be logged.

5.3 PWPA submitted to DENR the position that laws and/or regulations are prospective and not retroactive in application.

5.4 PWPA proposed the use of species other than dipterocarps e.g. bagras, *A. mangium* because of uncertainty of availability of dipterocarp planting materials when needed.

5.5 PWPA requested DENR that 1st quarter deposit be postponed to February 5, 1990 due to late approval of IAOP and that 2nd quarter's to April 20, 1990 due to many prior holidays.

6. PWPA requested DENR that license fees be based on new ACC to be equitable.

7. PWPA sent several letters to DENR requesting the expediting of PTPA extension/renewal. PWPA also circularized to PTPA holders to submit to DENR required data to expedite their PTPA extension/renewal.

8. On many MPFD meetings, PWPA has expressed the serious implications such recommendations can usher in, especially on the drastic reduction of AAC and/or timber production.

5.1 The DENR ruled that the use of RTF deposit shall be on the basis that for every one hectare logged, one hectare of open denuded area will have to be reforested (DENR Special Order No. 1154, Series 1989)

5.2 The DENR approved this request.

5.3 The DENR has not as yet commented on this issue.

5.4 The DENR denied the proposal.

5.5 The DENR approved this request.

6. The DENR approved this request effective March 30, 1990 and that excess payment already made can be credited to future payment of annual license fees.

7. Many PTPA's have not been renewed/extended to date.

8. The DENR has taken cognizance of these serious implications, voiced out not only by PWPA but other concerned, independent groups. DENR accordingly will be reviewing MPFD recommendations.

Congress

1. Senate Bill No. 1404, An Act to Protect the Forest by Banning Logging Operation in certain Provinces sponsored by Senator H. Alvarez, has been encountering opposition in the Senate for other senators want a total logging ban instead.
1. PWPA has submitted to almost all senators the position countering a total logging ban. Also PWPA has continued its campaign against a total logging ban using various forms of media.
1. Senate Bill 1404 to date is still at its second reading undergoing intense debate in the Senate.
2. House Bill No. 22401 increasing forest charges.
2. PWPA has submitted its position that very high forest charges as proposed in the bill would have adverse effects on the viability of the industry and/or prices of timber products in the markets.
2. Still pending calendaring in the Senate.

Media

1. Adverse publicity against the wood industry being waged by conservation movements through various forms of media.
1. PWPA has tried to counter such adverse publicity or misinformation via the press, radio, TV and in public fora, often with personal appearances of key officers of PWPA.
1. Intense and relentless has been the publicity against the industry and invariably decision or policy-makers have reacted thereto by proposing or imposing various forms of operational constraints.
2. Global campaign for the boycott of tropical timber products importation.
2. PWPA has been participating with regional and international organizations notably IHPA, SEALPA (now ATTO), APPF, etc. in the campaign to neutralize headways already gained by Greenpeace movement.
2. Greenpeace campaign is still on and at a higher pitch and scope.





NOTES TO FINANCIAL STATEMENTS

1. ORGANIZATION

The Philippine Wood Products Association, Inc. (PWPA) is an association of corporations, partnerships and individuals involved in logging, sawmilling, veneer and plywood manufacture, wood preservation, and other related activities. Incorporated as a nonstock, nonprofit corporation, the Association aims to achieve unity in the wood industry under a single integrated association that would serve as spokesman for the entire wood industry in its continuing dialogue with government authorities. Its services, programs and activities are all geared towards the promotion and development of the lumber and plywood industry.

2. DEPRECIATION POLICY

Property and equipment are carried at cost less accumulated depreciation. Depreciation is computed on the straight-line method based on the estimated useful lives of the assets ranging from 5 to 15 years.

3. ASSOCIATION'S REGIONAL CHAPTERS

The Association maintains a number of regional chapters within the Philippines. These chapters (organized during the latter part of 1979 and during 1980) act as extensions of the Association in their respective regions. Dues collected by these chapters are turned over to the Association. Twenty percent of such collections are remitted back to the chapters to cover their administrative expenses.
